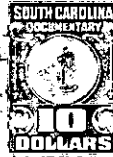
JAMES R. CULBERTSON and DORIS B. CULBERTSON, Their Heirs and Assigns:

M. C. Office for Greenville County in Plat Book GG at Pages 32-33, and having the following metes and bounds, to wit:
