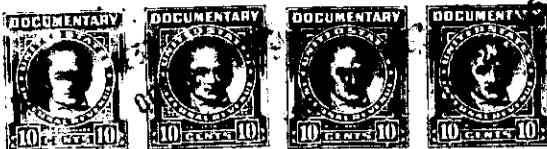

KNOW ALL MEN BY THESE PRESENTS That I, MACK E. HENRY,  
in the State aforesaid,

in consideration of the sum of Nine Thousand Two Hundred Fifty and No/100ths (\$9,250.00) DOLLARS,  
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto S. CARLETON ULLOM AND LUCILLE R. ULLOM:

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 2 as shown on a plat prepared by T. C. Adams, dated January 20, 1956, entitled "Property of Mack E. Henry" recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book JJ at page 100, and having according to a more recent plat prepared by Piedmont Engineering Service, dated July 17, 1957, entitled "Property of S. Carleton Ullom & Lucille R. Ullom" the following metes and bounds:

BEGINNING at an iron pin on the Western side of Keith Drive, which iron pin is located 107.2 feet in a Northwesterly direction from the Northwestern corner of the intersection of Keith Drive and Eisenhower Drive, and running thence S. 75-03 W. 150 feet to an iron pin; thence N. 16-02 W. 82.05 feet to an iron pin at the joint rear corner of Lots Nos. 1 and 2; thence with the line of Lot No. 1, N. 77-28 E. 150 feet to an iron pin on the Western side of Keith Drive; thence with the Western side of Keith Drive, S. 16-15 E. 75 feet to the point of beginning.

This is a portion of the property conveyed to the grantor herein by deed of S. C. Fleming and Mellie Fleming, dated January 20, 1956, and recorded in the R.M.C. Office for Greenville County in Deed Book 543 at page 489.
