STEVENS & CO., INC. owning property and having a a corporation chartered under the laws of the State of Delaware and ~~XXXXXX~~ place of business at Greenville in the State of South Carolina, for and in consideration of the sum of One Thousand One Hundred Eighty and 59/100ths (\$1,180.59)--- --- dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto EUGENE RACKLEY:

All that piece, parcel or lot of land situate, lying and being on the South-eastern side of Cottingham Street near Monaghan Mills in the County of Greenville, State of South Carolina, being known and designated as Lot No. 56 as shown on a plat entitled "Monaghan Subdivision, Greenville, S.C." made by Piedmont Engineering Service, Greenville, S.C., August 9, 1954, and recorded in the R.M.C. Office for Greenville County in Plat Book GG, at pages 86 and 87, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southeastern side of Cottingham Street at the joint front corner of Lots Nos. 55 and 56, and running thence with the line of Lot No. 55 S. 13-28 E. 156.9 feet to an iron pin in the line of Lot No. 53; thence with the line of Lot No. 53 S. 79-06 E. 40.5 feet to an iron pin in the rear line of Lot No. 51; thence with the rear lines of Lots Nos. 51 and 50 N. 54-50 E. 46.8 feet to an iron pin at the joint rear corner of Lots Nos. 56 and 57; thence with the line of Lot No. 57 N. 13-28 W. 156.3 feet to an iron pin on the Southeastern side of Cottingham Street; thence with the Southeastern side of Cottingham Street S. 76-32 W. 80 feet to the point of beginning.

This conveyance is made subject to restrictive covenants applicable to Monaghan Subdivision recorded in the R.M.C. Office for Greenville County in Deed Book 509, at page 443, and to an easement for utilities service dated October 11, 1954, given by J.P. Stevens & Co., Inc., to Duke Power Company and recorded in the R.M.C. Office for Greenville County in Deed Book 510 at page 317.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, his ~~XXXXXX~~ heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and his ~~XXXXXX~~ heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
