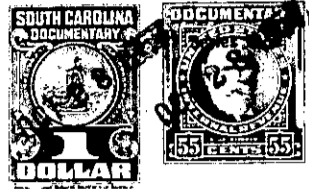

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to
be heard on the 25th day of SEPTEMBER 1957
and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged
and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN,
Master in and for the County aforesaid, to Allen Littlefield
for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear:

NOW, Therefore, Know all Men by these Presents, that I, E. INMAN, Master, in and for the County
of Greenville aforesaid, by virtue of the aforesaid decree, upon receipt of \$100.00

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release
unto the said Allen Littlefield

All those two certain parcels of land containing 6.15 acres and 5.02 acres
respectively, in Bladys Mountain Township, Greenville County, Greenville,
South Carolina, as shown on plat made by S. S. Hill et al on the 15th day of
1957 and being more particularly described as follows:

2.15 Acre Tract: BEGINNING at a pin in the line of the 35.11 acre tract
to be conveyed to W. W. Hornor, Jr. and running thence N. 17-30 E. 417.4
feet to a pin; thence N. 87 E. 350 feet to a pin in the line of the Hornor
tract; thence with the line of said tract the following courses and
distances: S. 30-30 W. 163 feet; S. 32-30 W. 120 feet; S. 33-30 W. 223
feet; S. 30-40 W. 120.7 feet to the beginning corner.

5.02 Acre Tract: BEGINNING at a pin near a branch on line of the Hornor
tract to be conveyed by the Master, and running thence N. 27-30 W. 303.5
feet; thence N. 38-30 W. 442.2 feet to a pin; thence S. 39-30 E. 461.5
feet; thence S. 57-30 E. 59.3 feet; S. 43-30 W. 65 feet; S. 72-15 W. 37
feet; S. 55 W. 36 feet; S. 16 W. 73 feet; S. 33 W. 38 feet; S. 37-30 W.
77 feet; S. 65 W. 114 feet; S. 67-15 W. 224 ft. to the point of beginning.
