in consideration of the sum of Thirty-seven Hundred Fifty and no/100 (\$3,750.00) in the State aforesaid, DOLLARS,

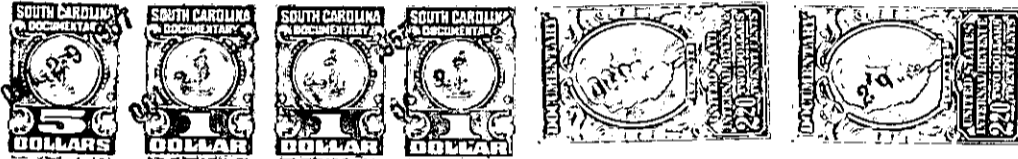

ALL that certain piece, parcel or lot of land situate lying and being in Butler Township in the City of Greenville, County of Greenville, State of South Carolina and being known and designated as Lot No. 14 of Block F of the subdivision known as Fair Heights and having according to a plat of said property, which is recorded in the R.M.C. Office for Greenville County in Plat Book F at Page 257 the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Brookdale Avenue at the joint front corners of Lots 14 and 15 of Block F and running thence S. 58-40 E. 150 feet to an iron pin; thence S. 31-20 W. 50 feet to an iron pin; thence N. 58-40 W. 150 feet to an iron pin on Brookdale Avenue; thence with said avenue N. 31-20 E. 50 feet to the point of beginning.
