Know All Men by These Presents:

That Janie Davis in the State aforesaid, in consideration of the sum of Five and no/100 - - - - - DOLLARS, and love and affection, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Otis Davis, his heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina, containing one-half acre, more or less on the Northwestern side of Davis Road, as shown on a plat of property of the Richard Davis Estate, surveyed February, 1941, by Dalton and Neves and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of Davis Road at the intersection of Old Jacob Road, and running thence along the Southwestern side of Old Jacob Road 124 feet to a point; thence in a Southern direction 199 feet to a point on Davis Road; thence along the Northwestern side of Davis Road N.40-10 E. 165 feet to the point of beginning, said property being in the shape of a triangle.

This being a portion of the property conveyed to the grantor by Hettie Davis on March 14, 1914 by deed recorded in Deed Book 28 at page 300.

Grantor to pay 1957 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
