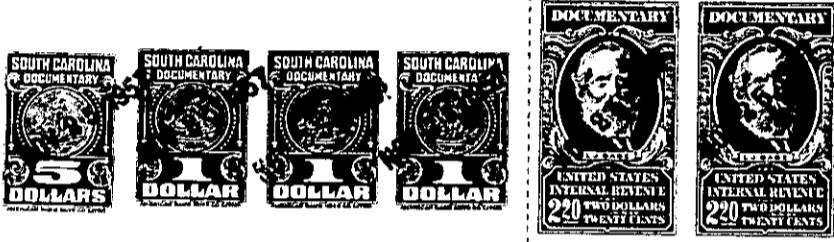

James Williams in the State aforesaid, in consideration of the sum of Four Thousand and no/100 DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. E. Shaw, Jr., his heirs and assigns:

All those pieces, parcels or lots of land in Greenville Township, County of Greenville, State of South Carolina, being known and designated as lots nos. 57 and 58, as shown on plat of property of P. L. Bruce made by R. K. Campbell April, 1950 and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "W" at page 171, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on an unnamed street, which iron pin is the joint front corner of lots 56 and 57, and running thence along the westerly side of said unnamed street S. 34-55 W. 90 feet to an iron pin; thence S. 64-10 W. 161 feet to a point in branch; thence along said branch N. 13-04 E. 183.7 feet to a point at the joint rear corner of lots 57 and 58; thence continuing along said branch N. 8-44 E. 66.9 feet to a point, the joint rear corner of lots 56 and 57; thence along the joint line of lots 56 and 57 S. 55-05 E. 176.5 feet to the point of Beginning.
