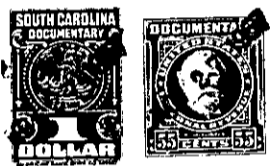
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Faris Green and his heirs and assigns forever:

All of that certain parcel or lot of land situated on the south side of Grove Street, near the City of Greer and southward therefrom, in Chick Springs Township of Greenville County, State of South Carolina, and being Lot No. 38 of Pleasant Heights Development, property of R.A. and I.B. Dobson according to survey and plat by H.L. Dunahoo, Surveyor, dated September 4, 1950, recorded in Plat Book "T", pages 274 and 275, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the south side of Grove Street, corner of Lots Nos. 37 and 38, and runs thence S. 5-00 W. 185 feet to an iron pin, rear corner of Lot No. 47; thence along Lot No. 47, S. 84-30 E. 100 feet to an iron pin, corner of Lot No. 39; thence along the line of said Lot No. 39, N. 5-00 E. 185 feet to Grove Street; thence along said Street, N. 84-30 W. 100 feet to the beginning corner.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
