All that lot of land with the improvements thereon situate on the northeast side of Sylvan Way and Brookside Way, in the City of Greenville, County of Greenville, State of South Carolina, shown as all of Lots 76, 77 and 78, on plat of Marshall Forest, prepared by Dalton & Neves, Engineers, October 1928, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "H" at Pages 133 and 134, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Sylvan Way at joint front corner of Lots 78 and 79, and running thence along the joint line of said lots N. 45-20 E. 279.5 feet to an iron pin on the south side of a 10 feet strip reserved for utilities; thence along the south side of said 10 feet strip S. 54-40 E. 76.1 feet to an iron pin at the joint rear corner of Lots 75 and 76; thence along the joint line of said lots S. 45-20 W. 303.5 feet to an iron pin on the north side of Sylvan Way, where same intersects with Brookside Way; thence along the north side of Brookside Way and Sylvan Way N. 36-25 W. 50.5 feet to an iron pin; thence along the north side of Sylvan Way N. 36-25 W. 25.2 feet to the point of beginning.
