John P. Faris, his heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the easterly side of Birdfield Drive, near the City of Greenville, S. C., and being shown as Lot No. 5 on the plat of Birdfield as recorded in the RMC Office for Greenville County, S. C. in Plat Book GG, page 91, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Birdfield Drive, joint front corner of Lots 5 and 6, and running thence along the common line of said lots S 56-05 E 276.3 feet to an iron pin; thence S 30-19 W 100.05 feet to an iron pin, joint rear corner of Lots 4 and 5; thence along the common line of said lots N 56-05 W 282.8 feet to an iron pin on the easterly side of said Drive; thence along said Drive N 33-55 E 100 feet to an iron pin, the point of beginning.
