Received of the SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY ONE AND Dollars in consideration of which (We) hereby grant said Company, its associated and allied companies, their respective licensees, successors and assigns, the right to construct, operate and maintain a line of communication consisting of such poles, wires, cables, conduits, guys, anchors and other necessary appurtenances as from time to time are required upon, across, over and/or under that certain tract of land situated in GREENVILLE County, State of SOUTH CAROLINA, to-wit:
THAT TRACT OF LAND BOUNDED ON THE NORTHEAST BY THE BOILING SPRINGS ROAD AND BOUNDED ON THE WEST BY ALVIN HUDSON AND ON THE SOUTHWEST BY J.H. COOPER AND ON THE SOUTH BY J.A. WARD.
