Campbell and Arlie C. Campbell, their heirs and assigns forever, all that piece, parcel, or lot of land lying and being in Highland Township, Greenville County, state of South Carolina and having the following metes and bounds and courses and distances:

Beginning on a stone, old corner between Campbell and Morrow lands, and running thence S 65.40 E 176 feet to a point in new road; thence down said road N 2.30 E 395 feet to old line dividing Campbell and Morrow lands; thence S 28.00 W 369 feet along old line to the beginning corner. The above described property contains 74/100 Acres more or less.
