Dickens and Joe Neva Turner as shown on a plat thereof made by Terry T. Dill September 3, 1955, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING, at an iron pin on South Carolina Highway S-22 at the corner of the E. P.
