

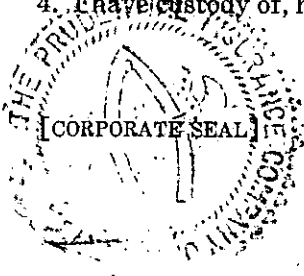
This is to certify that:
