Jack L. Tollison:

All that piece, parcel or lot of land situate, lying and being on the Southern side of Thomas Street near Monaghan Mills in the County of Greenville, State of South Carolina, and known and designated as Lot No. 24 as shown on a plat entitled "Monaghan Subdivision, Greenville, S.C." made by Piedmont Engineering Service, Greenville, S.C.; August 9, 1954, and recorded in the R.M.C. Office for Greenville County in Plat Book GG, at pages 86 and 87, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Thomas Street at the joint front corner of Lots Nos. 23 and 24, and running thence with the line of Lot No. 23 S. 19-25 E. 175 feet to an iron pin in the rear line of Lot No. 12; thence with the rear lines of Lots Nos. 12 and 11, N. 71-58 E. 71 feet to an iron pin at the joint rear corner of Lots Nos. 24 and 25; thence with the line of Lot No. 25 N. 14-50 W. 175 feet to an iron pin on the Southern side of Thomas Street; thence with the Southern side of Thomas Street S. 72-14 W. 85 feet to the point of beginning.

This conveyance is made subject to restrictive covenants applicable to Monaghan Subdivision recorded in the R.M.C. Office for Greenville County in Deed Book 509 at page 443; to an easement for utilities service dated October 11, 1954, given by J.P. Stevens & Co., Inc. to Duke Power Company and recorded in the R.M.C. Office for Greenville County in Deed Book 510 at page 317; and to an easement for drainage as shown on the plat hereinabove referred to.

This is the identical property conveyed to the grantor herein by deed of J.P. Stevens & Co., Inc., dated January 7, 1958, and recorded in the R.M.C. Office for Greenville County in Deed Book at page .

The grantee herein assumes and agrees to pay the balance due on that certain mortgage given by the grantor herein to Carolina Federal Savings and Loan Association dated January 7, 1958 in the original amount of \$6,800.00, and recorded in the R.M.C. Office for Greenville County in Mortgage Book at page .

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, his Heirs and Assigns forever. And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
