PAUL P. HEARN and ADA K. HEARN, their heirs and assigns forever,

ALL that lot of land in Butler Township, Greenville County, South Carolina, being shown and designated as Lot Seven (7) as shown on a plat of Section II of Lake Forest Heights, made by Piedmont Engineering Service in May, 1957 and recorded in the Greenville County R. M. C. Office in Plat Book "KK", at page 105, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southeast side of Greenbrier Road at the joint front corners of Lots #7 and #8, and running thence with the line of Lot #8, S. 58-54 E., 248.8 feet to an iron pin; thence S. 08 E., 90 feet to a pin; thence S. 85-39 W., 210.2 feet to an iron pin at the rear corner of Lot #6; thence with the line of Lot #6, N. 22-24 W., 204.1 feet to a pin on Greenbrier Road; thence with Greenbrier Road, N. 69-54 E., 50 feet to an iron pin; thence continuing with Greenbrier Road, N. 44-30 E., 40 feet to the point of beginning.
