Howard and his heirs and assigns forever:

All of that parcel or lot of land in Chick Springs Township of Greenville County, South Carolina, located about one mile south from the City of Greer, designated as Lot No. 52 on a plat of property known as Woodland Heights, property of I.M. Wood Estate, said plat made by H.S. Brockman, Surveyor, dated October 28, 1955, recorded in the R.M.C. Office for Greenville County in Plat Book GG, at page 151, and having the following courses and distances:

BEGINNING at an iron pin in the Western line of the J. Waymon Smith Road, joint corner of Lots Nos. 51 and 52, and running thence along the Western boundary of said road, N. 39-55 W. 98.3 feet to an iron pin; thence S. 39-20 W. 248 feet to an iron pin at the corner of Lot No. 53; thence along the Eastern boundary of this lot, S. 39-15 E. 73 feet to an iron pin at corner of Lot No. 51; thence along the northern boundary of this lot, N. 45-18 E. 245.5 feet to the beginning corner.

The above lot is hereby conveyed subject to the Protective Covenants applicable to all the lots in this subdivision known as Woodland Heights, near Greer, S.C., which are of record in the R.M.C. Office for Greenville County in Deed Book 539, page 129, R.M.C. Office for Greenville County.
