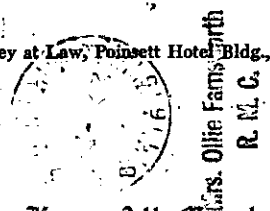

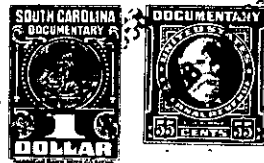
Howard L. and Kathleen Irvin, their heirs and assigns:

ALL that piece, parcel or lot of land being known and designated as lot 136, Pine Forest, as shown by a plat thereof, made by Madison H. Woodward, Engineer, said lot having the following metes and bounds:

BEGINNING at an iron pin on Charles Drive, joint front corners of lots 134 and 136 and running N. 0-29 E. 201 feet to an iron pin on the corner of Pine Lake Circle and Charles Drive; thence along Pine Lake Circle N. 25-0 W. 102.7 feet to an iron pin, joint corners of lots 136 and 135; thence along the line of lots 136 and 135 S. 0-29 W. 265 feet to an iron pin in the line of lot 134, at joint rear corners of lots 136 and 135; thence along the line of lots 134 and 136 S. 89-31 E. 80 feet to an iron pin on Charles Drive, the point of beginning.

Restrictions: The above described property is not to be sold, rented or otherwise disposed of to any Negro or person of African descent. No residence shall be built costing less than \$2000.00. No residence shall be erected on said lot nearer than 25 feet to the front line, and no residence shall be built on said lot unless it have 50 feet or more frontage.
