All that certain piece, parcel or lot of land, with the buildings and improvements thereon; lying and being at the easterly corner of the intersection of Pine Creek Drive and Marlboro Drive, near the City of Greenville, S. C., and being shown as Lot No. 268, Section 3, on the plat of Belle Meade as recorded in the RMC Office for Greenville County, S.
