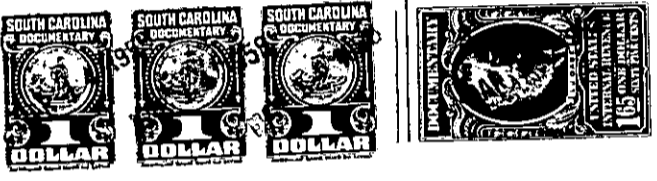
Know All Men by These Presents:

Arrowood and in the State aforesaid, in consideration of the sum of TWELVE HUNDRED AND FIFTY AND NO/100 (\$1250.00)----- DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John L. Arrowood, his heirs and assigns:

ALL that lot of land in Greenville County, South Carolina known and designated as Lot #23 on Crestmore Drive in a subdivision known as Grand-View, as shown by a plat thereof made by Woodward Engineering Company, March, 1957, and recorded in the Greenville County R. M. C. Office in Plat Book "KK", at page 93, and having, according to said plat, the following metes and bounds:

BEGINNING at a pin on the southern side of Crestmore Drive at the joint front corner of Lots #24 and #23 and running thence with the southern side of Crestmore Drive, N. 74-17 E., 60 feet to a pin at the corner of Lot #22; thence with the line of Lot #22, S. 15-43 E., 156 feet to a pin in the rear line of Lot #11; thence with the rear lines of Lots #11 and #10, S. 72-35 W., 60.02 feet to a pin at the rear corner of Lot #24; thence with the line of Lot #24, N. 15-43 W., 157.8 feet to the point of beginning.
