to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said B. W. Burdette, his heirs and assigns: all that certain piece, parcel or tract of land in Austin Township, Greenville County, State of South Carolina, located on the south side of public road leading off the Jonesville Road, approximately 3 miles East from the town of Simpsonville, S. C. adjoining lands of P. G. and C. J. Jones on the South and on the West by S. T. Cooper, and on the North and Eastern direction by the above mentioned road to Horse Pen Creek at beginning corner, and having the following metes and bounds, to wit:

BEGINNING at a point on the south side of bridge over Horse Pen Creek and running up the South side of Horse Pen Creek to a point opposite the old Holland S. Eng., thence to center of creek and up the center of creek to S. T. Cooper's line to an iron pin, and better described in 3 D paragraph of Deed from J. B. League to P. G. & C. J.
