All that certain lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as lot No. 72, as shown on a plat of Section 4 of the Dunean Subdivision of J. P. Stevens & Co., Inc. prepared by Pickell and Pickell, Engrs., recorded in Plat Book "S" at Page 173, and being more particularly described, according to said plat as follows:

BEGINNING at an iron pin on Hutchins Street, joint front corner of lots Nos. 71 and 72, which pin is 56 feet from the intersection of Hutchins and Smith Streets, and running thence with joint line of said lots, N. 58-09 E. 80.3 feet to an iron pin in a 15 foot alley; thence with said alley, S. 30-39 E. 54 feet to an iron pin, joint rear corner of lots Nos. 72 and 73; thence with joint line of said lots, S. 58-09 E. 81.6 feet to an iron pin in Hutchins Street; thence with said street, N. 31-51 E. 54 feet to the beginning corner.
