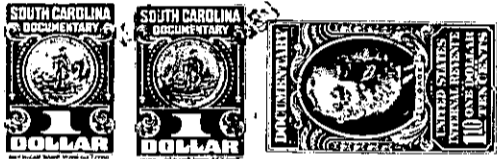
Harry A. Olson and Catherine G. Olson, their heirs and assigns, forever,
