P. MEDLOCK, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, within the corporate limits of the City of Greenville, and being known and designated as Lot 11 of a subdivision known as Hutton Court, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book NN at Page 101, and having the following metes and bounds, to wit:

BEGINNING at a point on the Eastern side of Hutton Court at the joint front corner of Lots 10 and 11 and running thence N 73-39 E 173.9 feet to a point at the joint rear corner of Lots 10 and 11; thence S 20-08 E 38.2 feet to a point; thence S 13-38 W 30.9 feet to a point at the joint rear corner of Lots 11 and 13; thence S 73-39 W 161 feet to a point on the Eastern side of Hutton Court at the joint corner of Lots 11 and 12; thence with the Eastern side of Hutton Court N 16-21 W 65 feet to the point of beginning.
