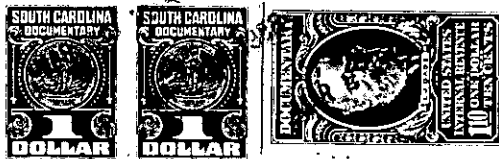
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. G. CHILDRESS and HAZEL R. CHILDRESS, Their Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 33 of a subdivision known as Woodbriar, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book EE at Page 6, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northwestern side of Woodbriar Court at the joint front corner of Lots 32 and 33 and running thence N 50-35 W 165.5 feet to a point at the joint rear corner of Lots 32 and 33; thence S 44-45 W 75.3 feet to a point at the joint rear corner of Lots 33 and 34; thence S 50-35 E 172.6 feet to a point on the Northwestern side of Woodbriar Court at the joint front corner of Lots 33 and 34; thence with the Northwestern side of Woodbriar Court N 39-25 E 75 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.
