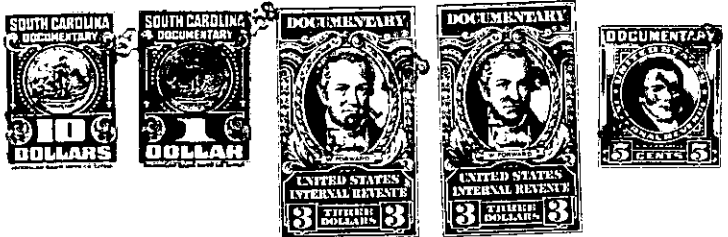
in consideration of the sum of Five Thousand Two Hundred Fifty and No/100ths (\$5,250.00)---

All that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lot No. 20, as shown on a plat of property of E.P. Kerns, recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book W at page 17, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southeastern side of Haviland Drive at the joint front corner of Lots Nos. 19 and 20, and running thence with the line of Lot No. 19 S. 70-21 E. 150 feet to an iron pin; thence S. 19-39 W. 50 feet to an iron pin at the joint rear corner of Lots Nos. 20 and 21; thence with the line of Lot No. 21 N. 70-21 W. 150 feet to an iron pin on the Southeastern side of Haviland Drive; thence with the Southeastern side of Haviland Drive N. 19-39 E. 50 feet to the point of beginning.
