

Lot No. 87 - BEGINNING at an iron pin on the South line of Hickory Lane, joint front corner of Lots Nos. 86 and 87, and running thence along the Southern line of said street S 87-54 E 90 feet and S 86-00 E 100 feet; thence still with the line of said street two arcs (the chords of which are S 69-40 E 90 feet and S 45-48 E 50 feet); thence rounding the curve at the intersection of said Hickory Lane and Crapemyrtle Drive a curve (the chord of which is S 13-45 W 50 feet); thence with the Northwestern line of said Crapemyrtle Drive S 49-42 W 100 feet and S 50-39 W 122 feet to an iron pin, the joint corner of Lots Nos. 87 and 88; thence with the joint line of Lots Nos. 87 and 88 N 46-34 W 184.1 feet to an iron pin, the joint corner of Lots Nos. 86, 87 and 88; thence with the joint line of Lots Nos. 86 and 87 N 2-33 E 140.9 feet to the point of beginning.

Lot No. 121 - BEGINNING at an iron pin on the East line of West Round Hill Road, joint front corner of Lots Nos. 121 and 122, and running thence with the joint line of Lots Nos. 121 and 122 N 81-13 E 212.5 feet to an iron pin in line of Lot No. 131, joint rear corner of Lots Nos. 121 and 122; thence along the line of Lot No. 131 S 1-52 E 68 feet to an iron pin, joint corner of Lots Nos. 121 and 131 and 132; thence with the joint line of Lots Nos. 121 and 132 S 12-08 E 253.7 feet to an iron pin in the North line of East Round Hill Road, joint corner of Lots Nos. 121 and 132; thence with the Northern line of said street N 74-54 W 178.4 feet to the commencement of the curve at the intersection of West Round Hill Road and East Round Hill Road; thence a curve (the chord of which is N 29-21 W 35 feet); thence along the East line of said West Round Hill Road N 15-57 E 100 feet and N 0-38 W 111.9 feet to the point of beginning.

Lot No. 132 - BEGINNING at an iron pin on the North line of East Round Hill Road, joint front corner of Lots Nos. 121 and 132, and running thence with the joint line of Lots Nos. 121 and 132 N 12-08 E 253.7 feet to an iron pin, joint corner of Lots Nos. 121, 131 and 132; thence with the joint line of Lots Nos. 131 and 132 S 75-28 E 235 feet to an iron pin on the West line of said East Round Hill Road, joint corner of Lots Nos. 131 and 132; thence following the line of said street as it curves the following curves (the chords of which are S 24-24 W 135 feet, S 52-55 W 139.1 feet, N 81-02 W 64.3 feet, and N 81-08 W 50 feet) to the point of beginning.

These lots are subject to the protective covenants covering the Green Valley Sub-division which are recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 593, at page 297 (a copy of these covenants is being delivered to grantee along with this deed) and to any recorded easements or rights of way.

Grantee assumes and agrees to pay all state and county real estate taxes on the above lots for the year 1958.
