ALL that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, near the Lock's Stateion and about one mile east from the Southern Worsted Mill, lying north of the Piedmont & Northern Railroad, being known as the St. Mathew's Cemetery, plus an additional portion, and having the following metes and bounds:
