

All that piece, parcel or lot of land in the City of Greenville, Greenville County, State of South Carolina located on the Western side of Lockwood Avenue and being known and designated as the Northern portion of Lot Number 66 on a plat of Elletson Acres recorded in the R. M. C. Office for Greenville County in Plat Book "EE", Page 161 and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Western side of Lockwood Avenue at a point 4 feet North of the joint front corner of Lots Numbers 65 and 66 and running thence in a line parallel to the Northern side line of Lot Number 65, N. 88-37 E. 178 feet to an iron pin at a point 4 feet North of the joint rear corner of Lots Numbers 65 and 66; thence N. 1-23 W. 81 feet to an iron pin at the joint rear corner of Lots Numbers 66 and 67; thence along the Southern side line of Lot Number 67, N. 88-37 E. 181 feet to an iron pin on the Western side of Lockwood Avenue; thence along the Western side of Lockwood Avenue, S. 0-14 W. 81 feet to the iron pin at the point of beginning.
