All of that certain piece, parcel or lot of land with the buildings and improvements thereon, in Butler Township, Greenville County, State of South Carolina, being a portion of Lot No. 11 as shown on plat of Property of Sinking Fund Commission of School District No. 17-A which plat is recorded in the R.
