in consideration of the sum of Eight Hundred & Fifty & NO/100 (\$850.00) - - - - DOLLARS,

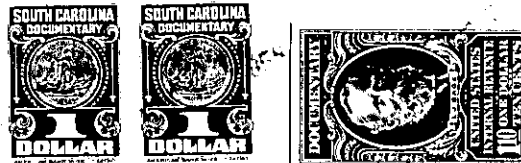
