All that certain parcel or tract of land situate, lying between Gum Springs Church and Mountain View School, in Oneal Township, Greenville County, State of South Carolina, containing Ten (10) Acres, more or less, and bounded by lands of Collins, Crain, Gilreath and others, and having the following courses and distances according to a plat thereof by W.A. Hester, Surveyor, dated July 18, 1925, to-wit:
