Marshall Dennis Lynn and Rheba Sprouse Lynn, their heirs and assigns:

All that piece, parcel or lot of land situate, lying and being in Bates Township, Greenville County, South Carolina, being shown and designated as Lot No. 48 of Grand View Heights, plat of which is recorded in Plat Book EE, Page 190, and having the following metes and bounds, to-wit:

BEGINNING at a point on Grand View Circle, joint front corner of Lots Nos. 48 and 49, and running thence with the line of said lots N. 13-35 W., 200 feet; thence N. 70-15 E., 100 feet; thence S. 13-35 E., 200 feet to a point on Grand View Circle; thence with Grand View Circle S. 70-15 W., 100 feet to the point of beginning.
