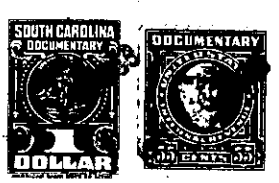

Know All Men by These Presents:

That I, Charles L. Smith in the State aforesaid,  
in consideration of the sum of Five Hundred & NO/100 (\$500.00) 00 - - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Levis L. Gilstrap, his heirs and assigns forever:

All that certain lot of land in Chick Springs Township, Greenville County, South Carolina, on the south side of Cardinal Drive, being known and designated as Lot No. 60 of Cardinal Park, property of Charles L. Smith as shown on plat made by R. K. Campbell, April 24, 1949, and recorded in the R. M. C. Office for Greenville County in Plat Book W. page 27, and having the following metes and bounds according to said plat:

BEGINNING at an iron pin on the south side of Cardinal Drive, at corner of Lot No. 59, and running thence with line of Lot No. 59, S. 21-58 E. 161.3 feet to an iron pin; thence N. 68-02 E. 35 feet to iron pin at corner of Lot No. 61; thence with line of Lot No. 61, N. 21-58 W. 167.5 feet to iron pin on the south side of Cardinal Drive; and thence with the south side of Cardinal Drive S. 57-54 W. 35.55 feet to the beginning corner, being ~~EXXIX~~ one of the lots conveyed to me by Wscar L. Ayers, by deed dated ~~July~~ 15th, 1955; and recorded in Book 530, page 59.

This property is conveyed subject to the following restrictions and conditions:  
(1) Said property is to be used for residential purposes only. (2) No residence shall be constructed on any lot in said subdivision at a cost of less than \$5,000.00. (3) No building shall be erected nearer than 30 feet from the street on which it faces. (4) No outside toilet permitted and all sewerage disposal is to be by approved septic tanks. (5) No residence is to be built on any lot or portion thereof, unless said lot has 50 feet or more of street frontage.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
