

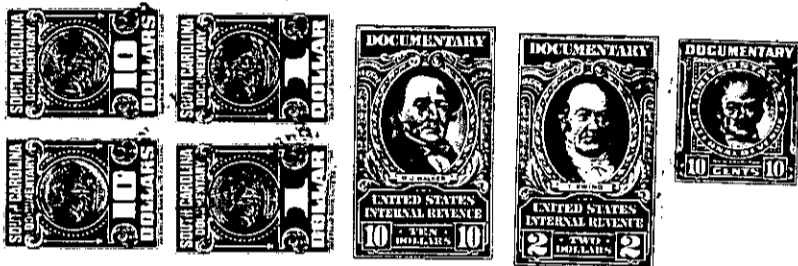

Cloyis Chambers, his heirs and assigns: All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown and designated as Lot No. 12 of Pine Grove Heights, plat of which is recorded in Plat Book Y, Page 87, and, according to said plat having the following metes and bounds, to-wit:

BEGINNING at a point on the south side of Pine Grove Road, joint front corner of Lots Nos. 12 and 13, and running thence with the line of said lots S. 25-30 W., 158 feet; thence N. 64-30 W., 100 feet; thence N. 25-30 E., 158 feet to a point on the south side of Pine Grove Road; thence with Pine Grove Road S. 64-30 E., 100 feet to the point of beginning.
