to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Claudia Bethel Jones, her heirs and assigns forever:

ALL those certain piece, parcel or lots of land in Greenville County, State of South Carolina, in Gantt Township, being known and designated as Lots Nos. 56 and 57 on Plat of Brookwood recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 27, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Harvard Drive, at the joint corner of Lots Nos. 55 and 56, and running thence with the line of Lot No. 55, N. 2-15 E. 165 feet to an iron pin; thence along the rear line of Lot Nos. 78 and 79, N. 87-45 W. 200 feet to an iron pin; thence along the line of Lot No. 58, S. 2-15 W. 165 feet to an iron pin on the Northern side of Harvard Drive; thence with said Drive, S. 87-45 E. 200 feet to the beginning corner.

THIS conveyance is subject to all easements and rights of way of record.

GRANTEE to pay taxes for the year 1958.

NO residence to cost less than Five Thousand (\$5,000.00) Dollars shall be erected on said lots; no residence shall be erected on any lot nearer than thirty-five (35) feet to the front line; no residence shall be erected on any lot unless said lot has fifty (50) feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and her Heirs and Assigns forever.
