Perone, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate off of Pleasantburg Drive, in the City of Greenville, S. C., and being designated as Tract No. 2 on the plat entitled "Holiday Inn Motel", recorded in the RMC Office in Plat Book KK, page 145, and having according to said plat the following metes and bounds, to-wit:
