and bounds, wo-wit:

BEGINNING at a concrete monument on the Northern side of Crane Avenue at the
joint front corner of Lots # 12 and 13, and running thence along the line of
said lots N. 33-30 E. 160.1 feet to an iron pin; thence along the rear of Lot
13 S. 58-24 E. 75.04 feet to an iron pin; thence along the line of Lot # 14
S. 33-30 W. 162.5 feet to an iron pin; thence along Crane Avenue N. 56-30 W.
75 feet to the point of beginning.
