Know All Men by These Presents:

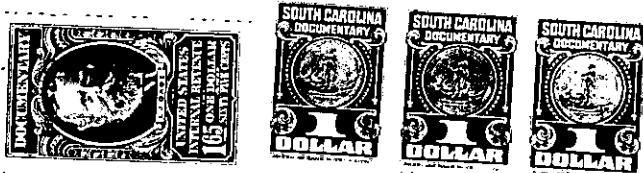

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Andrew B. Holmes, his heirs and assigns; the grantor reserves to himself the option to repurchase this property within eighteen months from the date of this instrument, according to the terms of the written agreement entered into this date with the grantee.

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on the South side of Dunbar Street, beginning at corner of lot now or formerly of Marcellus Tribble and running thence in a Westerly direction along Dunbar Street 65 feet to corner of lot now or formerly of R.D. Smith; thence along line of said lot in a southerly direction 100 feet; thence in an easterly direction 65 feet to point in line of lot now or formerly of Julius Gardiner; thence in a northerly direction along line of said lot and lot of Tribble 100 feet to the beginning corner.

This being the same lot of land conveyed to grantor by E. Godfrey Webster by deed dated January 2, 1947 and recorded in the R.M.C. Office for Greenville County in Vol. 304, Page 407.

This lot is shown on City and County Tax Maps as follows: District Number 17, Map Number 84, Blk. 3, Lot Number 11, and is situated between a 34 foot unnamed street, which is an extension of James Alley and South Calhoun Street.
