to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John A. Leppard, his heirs and assigns forever:

All that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the Southeast side of Bagwell Street, being shown and designated as lot # 24, on a plat of Valleydale recorded in Plat Book KK at Page 115, and being more particularly described as follows:
