All that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, within the corporate limits of the City of Greenville, and being known and designated as Lot Number 18 of Hollywood Subdivision, according to a plat made by Pickell and Pickell, Engineers, on June 4, 1947, and recorded in the RMC Office for Greenville County in Plat Book S at page 37, and having the following metes and bounds, to-wit:

Beginning at a point on the Western side of Hollywood Circle at the joint front corner of Lots 17 and 18 and running thence S. 75-30 W. 142.2 feet to a point at the joint rear corner of Lots 17 and 18; thence N. 04-45 W. 55.8 feet to a point at the joint rear corner of Lots 18 and 19; thence N. 75-30 E. 132.8 feet to a point on the Western side of Hollywood Circle at the joint front corner of Lots 18 and 19; thence with the Western side of Hollywood Circle S. 14-30 E. 55 feet to the point of beginning.
