All that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, on the Southern side of McCarter Avenue, being shown and designated as lot # 45, on plat of Lake Forest Heights, Section 1, recorded in Plat Book GG at Page 153, R.M.C. Office for Greenville County, and Having, according to said plat, the following metes and bounds:
