ALL that lot of land in Greenville County, South Carolina known and designated as Lot #39 of a subdivision known as Glendale Heights as shown by a plat thereof made by J. Mac Richardson, February, 1958 and recorded in the Greenville County R. M. C. Office in Plat Book "KK", at page 143, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the western side of Glendale Street at the corner of Lot #38 and running thence with the western side of Glendale Street, S. 6-45 E., 50 feet to a pin at the curve of the intersection of Glendale Street and Dresden Avenue; thence with said curve (the traverse being S. 38-15 W., 28.3 feet) to a pin on the northern side of Dresden Avenue; thence with the northern side of Dresden Avenue, S. 83-15 W., 110 feet to a pin at the rear corner of Lot #57; thence with the rear line of Lot #57, N. 6-45 W., 70 feet to a pin at the corner of Lot #38; thence with the line of Lot #38, N. 83-15 E., 130 feet to the point of beginning.
