TITLE TO REAL ESTATE

Fleury Imhoff, in the state aforesaid, in consideration of the sum of Two Thousand (\$2,000.00) Dollars to the grantors in hand paid at and before the sealing of these presents by the grantee (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto R. H. Green the following-described property, to-wit:

ALL That piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, situate on the southeasterly side of U. S. Highway 291 (By-Pass) adjoining property heretofore conveyed to grantee herein by grantors herein, as shown on plat of property of the McAlister Estate, prepared July 1953, (revised Dec. 27, 1957) by C. C. Jones, Civil Engineer, and having according to said plat the following metes and bounds, to-wit:

BEGINNING At a point on the southeasterly side of U. S. Highway 291, said point being S. 26-11 W. 500 feet from the intersection of the southwestern side of Laurens Road (U. S. Highway 276) and the southeasterly side of U. S. Highway 291, and running thence along the southeasterly side of U. S. Highway 291, S. 26-11 W. 10 feet to a point; thence turning and running S. 55-31 E. 500 feet to a point; thence turning and running N. 26-11 E. 10 feet to a point in line of property heretofore conveyed to the grantee; thence along the line of said property, N. 55-31 W. 500 feet to the point of beginning.

TOGETHER With all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
