to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. H. SITTON, his heirs and assigns forever:

AN undivided one-half interest in and to all that lot of land situate on the North side of U. S. Highway No. 123, near the City of Greenville, Greenville County, S. C., (Greenville to Easley South Carolina Road) being shown as Lots 138 and 139 on Plat of Riverdale, made by Dalton & Neves, Engineers, July, 1957, recorded in the RMC Office for Greenville County, S.
