P. MEDLOCK, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 3 of the property of W. T. Patrick and William R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book PP at Page 131, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northwestern side of Salem Court at the joint front corner of Lots 2 and 3 and running thence N 34-20 W 150 feet to a point at the joint rear corner of Lots 2 and 3; thence S 87-50 W 94.5 feet to a point at the joint rear corner of Lots 3 and 4; thence S 34-20 E 200.3 feet to a point on the Northwestern side of Salem Court at the joint front corner of Lots 3 and 4; thence with the Northwestern side of Salem Court N 55-40 E 80 feet to the point of beginning.
