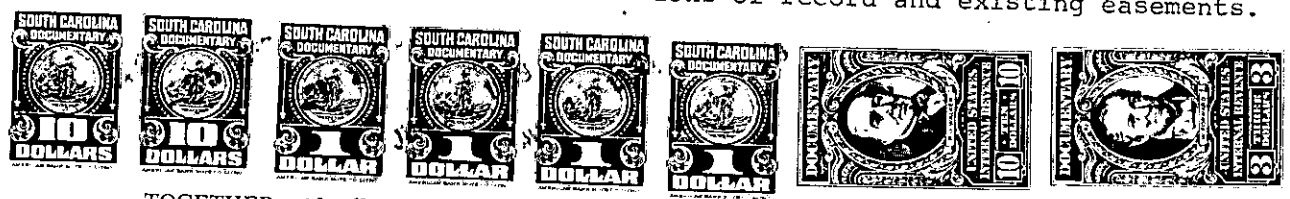
Know All Men by These Presents:

OZBURN, JR.

ALL That certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 48 on plat of Cedar Lane Gardens, dated August 27, 1955, recorded in the Office of the R.M.C. for Greenville County in Plat Book GG, Page 139, and having according to said plat the following metes and bounds, to-wit:

BEGINNING At an iron pin on the northeastern side of Gardenia Drive at the joint front corner of Lots 47 and 48 and running thence along the joint line of said lots, N. 37-01 E. 128.4 feet to an iron pin in the center of a 10-foot drainage easement, rear line of Lot 38; thence along the center of said easement and a portion of Lot 38, N. 43-11 W. 80 feet to an iron pin in rear line of Lot 37, joint rear corner of Lots 48 and 49; thence along the joint line of said lots, S. 39-21 W. 147.5 feet to a point on the northeast side of Gardenia Drive; thence along the northeast side of Gardenia Drive, S. 56-33 E. 85 feet to the point of beginning.

This property is subject to restrictions of record and existing easements.
