That I, WILLIAM R. TIMMONS, JR., in the State aforesaid, in consideration of the sum of SEVEN HUNDRED FIFTY AND NO/100 ---- (\$750.00) ---- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said HARVEY F. BAILEY and ILA BAILEY, Their Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 11 of a subdivision known as Woodbriar, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book EE at Page 6, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northwestern side of Marion Road at the joint front corner of Lots 10 and 11 and running thence N 58-58 W 175 feet to a point at the joint rear corner of Lots 10 and 11; thence S 31-02 W 72 feet to a point on the Northeastern side of Indigo Street at the joint rear corner of Lots 11 and 25; thence with the Northeastern side of Indigo Street S 58-58 E 160 feet to a point; thence following the curvature of the Northwestern intersection of Indigo Street with Marion Road (the chord of which is N 76-02 E 21.3 feet) to a point; thence with the Northwestern side of Marion Road N 31-02 E 57 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.

GRANTEE to pay 1958 taxes.
