Know All Men by These Presents:

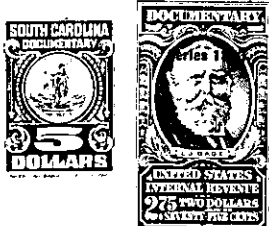
That I, Waco F. Childers, Jr., in consideration of the sum of Twenty-Five Hundred and No/100- DOLLARS, in the State aforesaid,

All that piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina and being known and designated as Lot No. 1 of White Horse Heights as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "BB", Page 135 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of White Horse Road, joint corner Lots Nos. 1 and 2 and running thence N. 76-35 E. 180 feet to an iron pin in the line of Lot No. 3; thence along the line of Lot No. 3 S. 19-20 E. 100 feet to an iron pin; thence S. 76-22 W. 200 feet to an iron pin on White Horse Road; thence along White Horse Road N. 7-57 W. 100 feet to an iron pin, the point of beginning.
