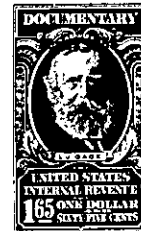

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina and being known and designated as Lot No. 8 on plat of Property of John G. Wilson as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book W, at Page 163 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Hillrose Avenue, joint front corner Lots Nos. 8 and 9 and running thence along Lot No. 9 S. 13-14 W. 155.4 feet to an iron pin; thence along Lot No. 7 N. 60-18 W. 160 feet to an iron pin on Galphin Drive; thence along the eastern side of Galphin Drive N. 35-51 E. 150 feet to an iron pin at the intersection with Hillrose Avenue; thence S. 60-18 E. 100 feet along Hillrose Avenue to the point of beginning.
